

TERMS & CONDITIONS

FOR PARTICIPANTS

By paying the registration and tour fees or accepting a scholarship, you are automatically agreeing to the following terms and conditions. Please read this entire document before paying the registration and tour fees or accepting a scholarship.

If/when I register and submit payments, I am automatically agreeing to all of the following terms:

- I confirm that the artwork that I am presenting and selling during Open Studios - Nevada County West is an original, authentic and certified creation of my own, made by my own hand and not a reproduction or forgery.
- I understand that there are no refunds on application or tour fee payments.
- I understand that one tour fee payment entitles me (one artist/gallery) to one listing on the website, one listing in the official Open Studios tour guide, inclusion in the official Open Studios 2025 Google Map (online), and the inclusion of one artwork in the Open Studios Preview Exhibition.
- I understand that if I choose to register as a group studio, that individual artist names will not be included in the listing.
- I understand that participation is contingent upon upholding and abiding by all terms and conditions, including being open for business and participation within the time frame of the event.
- In case of an emergency in which I am unable to keep open hours I will email openstudios@thecenterforthearts immediately, and share any changed/updated open hours via social media and mailing lists.
- I understand that my participation in the event requires that I adhere to and abide by all rules, regulations and laws governing the City, County and State of which I am conducting business in.
- I understand that if I am represented by a gallery or galleries, that I am 100% percent responsible for abiding by all terms of agreement with the gallery or galleries that represent me and hold harmless Open Studios - Nevada County West and it's producers, The Center for the Arts, for any issues that may arise due to my participation in the event.
- I understand that Open Studios - Nevada County West will be promoting the event through local newspapers, journals, social media, and their own emailing lists, but that there is no guarantee that visitors will attend the event or visit my own individual studio/exhibition space.
- I agree to indemnify, defend and hold harmless Open Studios - Nevada County West and its producers, The Center for the Arts, for any lack of attendance and any and all liabilities, claims, errors, omissions, losses, accidents and expenses caused by, arising out of, or in connection with, either directly or indirectly, Open Studios - Nevada County West.
- Open Studios - Nevada County West has the right to alter/edit/modify any information on artist profiles that does not suit the nature of the event or fit into the layout of the website.
- By submitting images of my work to Open Studios - Nevada County West I am giving them permission to use the images for promotion and/or marketing of the event.

- I understand that it is my responsibility to personally promote my open studio event through my own email lists, social media accounts, etc.
- I understand that my studio address cannot be changed or altered after registration officially closes.
- If I need to update or remove my listing for the printed Guide, I must do so before 5pm PST, May 23, 2025 by emailing openstudios@thecenterforthearts.org.
- Open Studios - Nevada County West and its producers, The Center for the Arts, are not responsible for the results of my participation in the event.
- If and when I register, I hereby agree to the terms and conditions of Open Studios - Nevada County West as outlined here.
- These terms and conditions may be updated at any given time without notice.

Additional Terms and Conditions for Scholarship Recipients:

- I have until 5pm PST, April 18, 2025 to accept a scholarship offer. If I do not accept the scholarship offer by 5pm PST on April 18, 2025 my scholarship will be given to the next candidate.
- I understand that, by accepting this scholarship, I agree to have a business sponsor named on my studio listing.
